ARTICLES OF INCORPORATION

OF

THE WOODLANDS RELIGIOUS COMMUNITY, INC.

We, the undersigned natural persons of the age of twenty-one years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE ONE

The name of the corporation is The Woodlands Religious Community, Inc.

ARTICLE TWO

The corporation is a non-profit corporation.

ARTICLE THREE

The period of duration is perpetual.

ARTICLE FOUR

The purposes for which the corporation is organized are:

- (a) To aid, promote, and provide for religious cooperation in The Woodlands in conjunction with the residents of The Woodlands and the congregations that will develop therein.
- (b) To acquire (by gift, purchase or otherwise), own, hold, improve, build on, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the corporation.

- (c) To borrow money in the name of the corporation, and mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred.
- (d) To lease, sell or donate to the State of Texas or to Harris and Montgomery Counties, any agency, subdivision, authority of instrumentality of said State or the Counties, or to any association or to any civic or other non-profit organization, any of the property or facilities acquired or constructed by the corporation when in the opinion of the Board of Directors such leasing, sale or donation is desirable for and beneficial to the religious and social welfare of the people of The Woodlands, upon such terms and conditions as the Board of Directors may deem acceptable.
- (e) To render direct financial assistance, to make direct contributions or grants of money, to make loans or advances to the State of Texas or to Harris and Montgomery Counties, or any agency, subdivision, authority or instrumentality of said State or the Counties, or to any civic or other non-profit organization, when in the opinion of the Board of Directors such assistance, contribution or grant is desirable and beneficial to the religious and social welfare of the people of The Woodlands.
- (f) To have and to exercise any and all powers, rights, privileges which a corporation organized under the Non-Profit Corporation Law of the State of Texas by law may now or hereafter have or exercise.

ARTICLE FIVE

The street address of the official registered office of the corporation is 345 Piney Point Road, Houston, Texas, and the name of its official registered agent is Richard Wheatcroft.

ARTICLE SIX

The corporation shall have not less than three (3) directors, except that the maximum number of directors shall be changed from time to time as provided for in the By-Laws adopted by the Board of Directors. The Board of Directors may be divided into classes and the term of office of the several classes need not be uniform. The number of directors constituting the initial board of directors of the corporation is three (3) and the name and address of the persons who are to serve as directors until the first annual meeting of the members, or until their successors are elected and qualified are:

Pursuant to Article 1396-4.03, Texas Non-Profit Corporation Act, The Woodlands Religious Community, hereby submits the following:

At a duly authorized meeting of the Board of Directors of The Woodlands Religious Community, Inc., held on September 10, 1975 at which a quorum was present and voting, the Articles of Incorporation were, by a unanimous vote of the Directors in office, there being no members having voting rights, amended as follows: Article Four, section (f) was deleted and replaced.

The old reading was: 'To have and to exercise any and all powers, rights, privileges which a corporation organized under the Non-Profit Corporation Law of the State of Texas by law may now or hereafter have and exercise."

The new Article Four, section (f), as adopted, reads:

"Notwithstanding any of the purposes above, this organization will not engage in any activities that an organization exempt under section 501 (c) (3) would be prohibited from engaging in."


